April 18 ACTION: Bob Sundberg, WHPA staff, would send Tom Paxson several recent CQM Committee work products and a link to all WHPA work products. Completed.

February 14 ACTION: Christian Weber, PG&E and Scott Higa, SCE, would report on the IOU billing analysis study at the March 2017 meeting. Ongoing.

Background: A study was being conducted, led by PG&E, regarding billing analysis for HVAC which would include CQM, CQR and Upstream program participants. The goal of the study was to produce a quantitative

Don Langston – you had to scroll through the linked document to page 5 to locate information about this update process. Then, they’d provided 294 pages of details. He’d found a few nuggets which suggested a more holistic approach rather than the past approach of only looking at individual energy efficiency measures, like RCA adjustments (refrigerant charge adjustments).

IOU CQM Program Updates

SCE CQM program summary (Scott Higa of SCE & Gretchen Egging of CLEAResult):

Gretchen Egging, CLEAResult – there had been a policy change regarding VFD installation energy savings and HVAC Optimization program incentives. Building owners could now take advantage of those technology upgrade incentives even after they’d graduated from the three-year program. Program staff was ramping up efforts to support contractor out-reach to their customers to inform them about this extended opportunity. Other news:

- A HUGE % increase in new participating units which had economizers
- Looked to be on-track to meet the increased energy savings goals for 2017

Scott Higa, SCE – the VFD upgrade was one of the most cost-effective energy efficiency measures in their program. Also, a large % of advanced digital economizer control upgrades were completed without VFD upgrades. They saw a great opportunity to reach back to past program participants and extend this opportunity to build on their previous upgrade, even beyond the time limit of the original program to have an even greater impact on all the units the program had originally touched.

Don Langston – asked whether the economizer upgrades included DCV (demand control ventilation) or for the great majority of those upgrades.

Scott Higa – the DCV component was evaluated by the CPUC and designated a TRC (total resource cost) of < 1 for many building types and applications as a standalone measure. This measure was, to the regulators, not cost-effective enough to approve any additional incentives for that additional feature. DCV was also required by code for certain building types.

Dale Rossi, FDSI – his firm had been involved with many buildings which considered VFD upgrades. Not because of the incentives but more related to the actual upgrade cost and estimated ROI. He asked what had changed to now make that upgrade more cost-effective for customers? His customers had chosen the ADEC – advanced digital economizer control – option rather than the Catalyst option, which included an integrated VFD, because of the incentive to cost comparison. Why would it be more attractive now? What message could they deliver to their past program customers?

Gretchen Egging, CLEAResult – she'd been informed that contractors were going back to past program participants because they sensed sales and profits to existing customers who were now outside the program.

Scott Higa – didn't have a ready answer but indicated they'd know pretty quickly whether the market would react favorably to the extended offer.

Don Langston – he asked Scott to follow-up with Bob Sundberg with an update on how and why this program extension would seem to make more, new sense to customers who had earlier chosen just the ADEC upgrade rather than the digital economizer upgrade with integrated VFD installation based on an evaluation of cost and incentives for each offering.

ACTION: Scott Higa and Gretchen Egging would follow-up to provide Bob Sundberg details about why their program had extended incentives to customers to upgrade to the integrated VFD/ADEC option (Catalyst) beyond the program three-year limit when those same customers had earlier chosen the ADEC alone option based on their earlier evaluation of costs and incentives for each offering.

PG&E CQM Program Summary (PG&E staff to be designated & Shayne Holderby of HSE)

Shayne Holderby, Honeywell Smart Energy – Shayne was unable to attend. Steve Varnum, HSE, provided an update.

- Program was going well
- Unit participation and kWh savings were both on target
- Proctor Engineering was providing field quality control (assurance) service, site inspections in addition to those provided directly by PG&E

SDG&E CQM Program Summary (Paul Thomas, SDG&E, David Cantanese, CLEAResult)

David Cantanese, CLEAResult – he was attending his first WHPA meeting and would work with Gretchen Egging to bring future program updates closer to the format used by SCE and PG&E.

- Commercial maintenance was a part of their commercial offering under the overall program title Premium Efficiency Cooling. It accounted for about 10% of that program budget.
- Off to a slow start in 2017
- Implementers were busy attempting to recruit new contractors to participate
- Very little was changed from the suite of offerings in 2016

Don Langston, Chair, welcomed David to the committee and looked forward to SDG&E regular participation.

CQM Committee 2017 Working Groups – Don Langston

Three different working groups were planned for 2017 to make greater progress outside of the full committee meetings.

Standard 180 User Guide – technical implementation

- The WG met on April 27 and reached agreement to focus on Section 4 Maintenance Plan Implementation for the user guide
- At the April 27 meeting, Shayne Holderby, HSE, presented and led discussion on the User Manual developed for PG&E HVAC Optimization program participants. The WG got a thorough tour of the manual and the contents directed both at implementing contractors and their staff as well as their customers.
- The WG was scheduled to meet again Tuesday June 20.
- Don Langston, who was temporarily leading the group, emphasized the need for a WG member to step up and help lead this group. The chair position didn't need to be permanent and could be rotated between WG members.

Standard 180 User Guide – customer communications (interview process to establish program goals, metrics and defining the value proposition)

Jan Peterson, XCSpec - James Graening, B2B Sales Excellence, had provided WG members with an overview of his commercial contractor sales training. He introduced the concept that establishing a maintenance agreement, from the sales perspective, was a process with well-defined stages. The service provider needed to understand who controlled this decision, past maintenance practices and client expectations/goals, the budgets available to support any proposed work as well as the decision-making phases and that meeting agendas needed to be presented and agreed to with the prospective client. They also needed to define metrics which would define the degree of program success. James focused on the initial structured meetings that were expected to not exceed 30 to 45 minutes. These meetings were intended to determine the degree of customer motivation (qualifying) to consider more comprehensive approaches to maintenance, determine which decision-makers needed to be involved, get at customer issues/pain points and important goals and a commitment to move ahead with further meetings to form a suitable maintenance program and contract for work.

One WG goal was to develop a draft narrative of those initial discussions/sales meetings. Jan planned to have the draft completed and distributed prior to the Standard 180 meeting Friday June 23 or early in July.

Don Langston thanked Jan for stepping up and leading this WG. He'd worked with James for several years and believed his skills and talents would be very valuable to the WG.

Commercial maintenance data specification (measurements required to calculate performance evaluation/scoring)

Don Langston – this WG had not yet been formed. The intent was to refine, revise and finalize a data specification initially developed for commercial installations by the CQI Committee. The data spec. would be

adapted to a commercial maintenance application and used as the basis for developing a means to evaluate unit/system performance to score and track the impact of more comprehensive maintenance practices.

IOU Billing Analysis Study – Christian Weber (PG&E) and Scott Higa (SCE)

Scott Higa, SCE – PG&E was leading this study and Christian was unavailable to attend this meeting. Scott shared what he knew of the study.

- AMI Billing Analysis Study – phase 1 was for residential HVAC. Phase 2, which was in process, was focused on commercial HVAC programs. Billing data was drawn from the SCE HVAC Optimization (QM) program as well as data which would be provided within a few weeks from the SCE commercial installation/renovation project. The CI data was primarily from NCI's study database. Billing analysis would be performed by Evergreen Consulting, PG&E's contractor. Evergreen was developing a random coefficients model to disaggregate energy use at the building meter to more specific loads, like all HVAC use. Their goal was to look at the actual change in HVAC energy use before vs. after a program intervention.
- Don Langston, Chair, asked when results might be expected. Scott Higa indicated that preliminary results were expected by the end of 2017.
- The SCE QI project collected data from 9 locations and from about 50 monitored packaged units. This submetered HVAC energy use was not readily available from other commercial HVAC/QM programs. That level of data collection had been out of scope for most energy efficiency programs. That was the detailed energy use at the HVAC unit data which SCE was providing the PG&E consultant for comparison with the disaggregated energy use modeling.

ACTION: Christian Weber, PG&E, and Scott Higa, SCE, would report on preliminary results of the AMI Billing Analysis Study. Preliminary results were expected by the end of 2017.

Closing Comments/Adjournment

Don Langston wanted to hold off scheduling the next full CQM Committee meeting until after the ASHRAE/ACCA SPC Standard 180 meeting. The meeting might be held in July or postponed to August.

The meeting was formally adjourned at 10:46 am PDT.
